## Completing the figure caption box at initial submission

To designate the order in which your files appear, use the dropdowns in the "order" column below. View your submission by clicking on HTML or PDF; be sure to check the PDF as this is what reviewers are most likely to access. **If your images do not show in the PDF, please try uploading the images as a .pdf file.** When you are finished, click "Save and Continue." 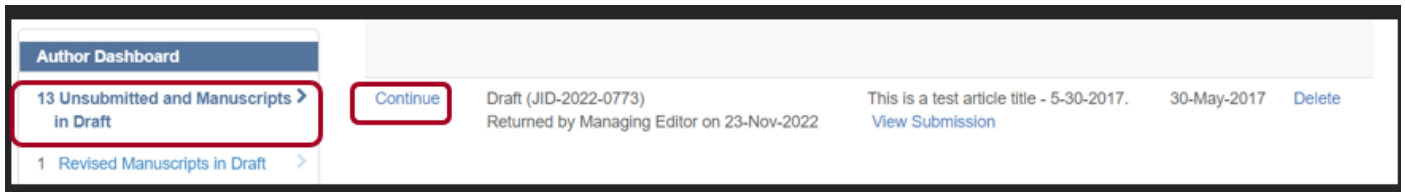

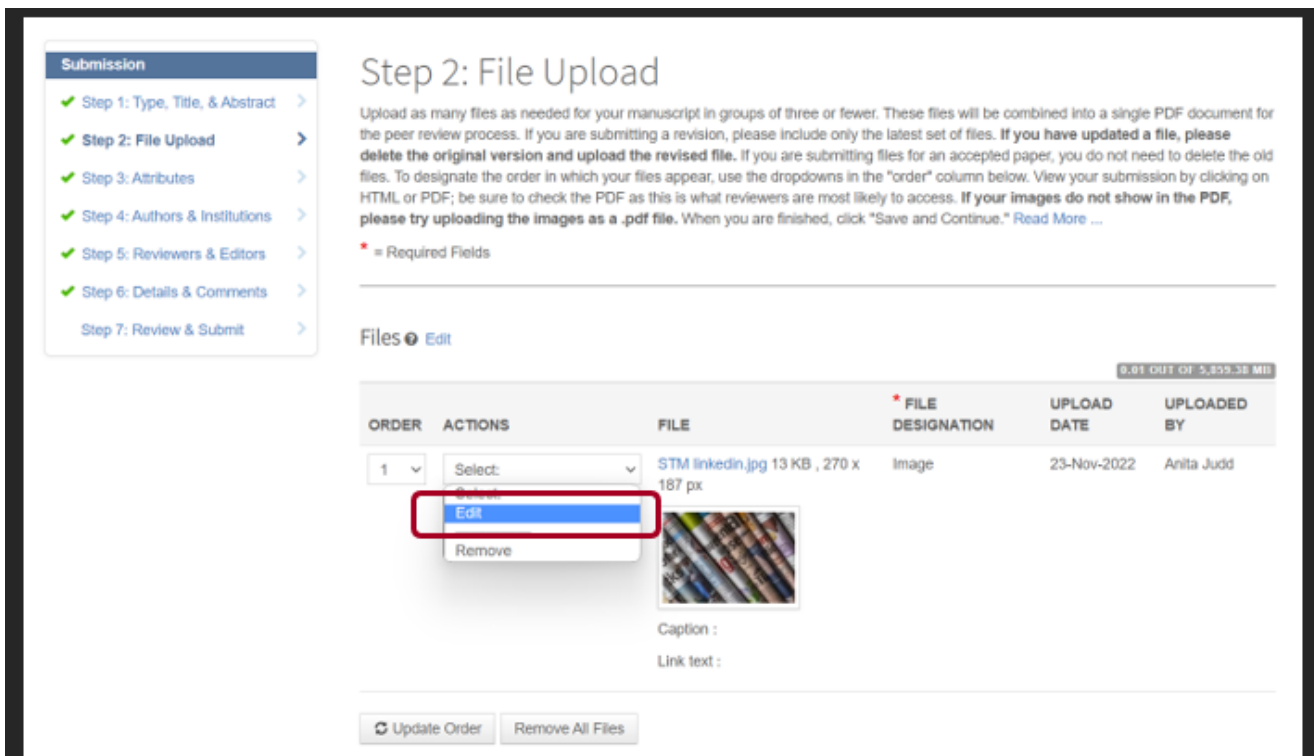

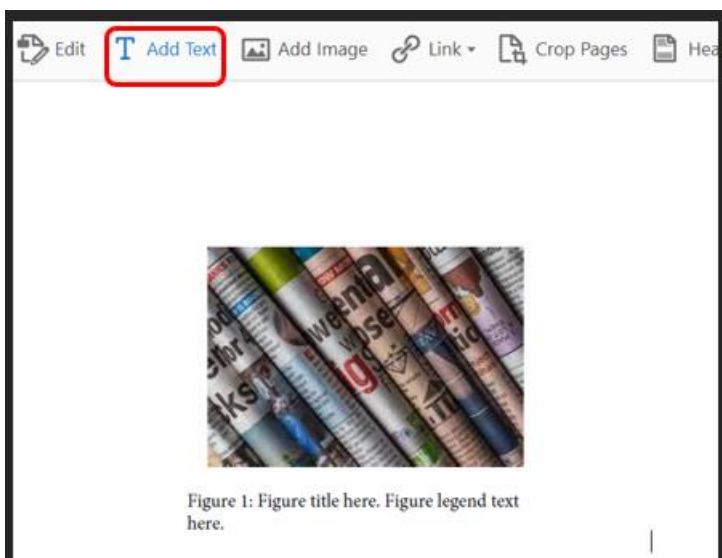
